CIRCULAR

Subject – Filling up of management seats

All principals of Private AHDP institutes having valid NOC from the state government are hereby informed to fill up 15% seats under management quota seats in Animal Husbandry Diploma Programme (2025-26). The guidelines shall be followed as under;

1. The applications should be invited through advertisement in leading newspapers giving wide publicity and clear directives to the applicants.
2. The admissions are to be done on the basis of merit drawn out of the total applicants.
3. The minimum qualification and age for management seats shall remain the same as has already been announced for state quota seats.
4. The essentiality of domicile of Rajasthan State is not applicable to management seats. The candidates belonging to other states are also eligible for management seat.
5. The reservation policy of Rajasthan as for regular State seats is required to be followed for management seats.
6. The whole process should be kept transparent. Record should be kept and preserved properly for scrutiny by the university or any.
7. The list of students admitted on management seats should be provided in the given format (copy enclosed) and sent to Coordinator AHDP by email (coordinator.ahdp@gmail.com) on or before 22.12.2025. The hard copy of the same shall also be submitted to The Coordinator (AHDP), College of Veterinary and Animal Science, Near Deen Dayal Upadhyay Circle, Bikaner 334 001.
8. While providing admissions on management seats, it shall be the responsibility of the respective AHDP institute to ensure that each and every candidate admitted on management seat possesses the requisite minimum eligibility criteria. Utmost care should be exercised to ensure the minimum eligibility criteria, without fulfilling which the students shall not be enrolled by the university. Under such circumstances, the sole responsibility in this matter shall lie with the AHDP institute.
9. The admission process on management seats should be finished by 22.12.2025 positively.
