Further, certified copies of KIRAYANAMA must be obtained from institutes running on rental accommodation. Any other educational programme or activity, if found running/operational in the premises of private AHDP institute, must be reported during inspection. The team is also required to ensure that examination hall of AHDP institute be equipped with CCTV Cameras.

The exact dates of visit shall be finalized in consultation with the Nodal Officer (Inspection & Affiliation) under intimation to the undersigned.
